

# Masjid Annur Membership Form

All current MA membership will expire with the new lunar year, so we urge everyone to become a member. It is through active membership that the strength of the community will be evident. A membership form is attached below for this purpose. The membership will give the member the privileges of voting.

**MEMBERSHIP CRITERIA:**

- 1) The membership of MASJID ANNUR shall consist of members who wish to abide by these bylaws and satisfy the membership requirements specified in Sections 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12 and 13 of this Article.
- 2) An applicant or renewing member shall testify in the basic beliefs of Islamic faith specifically:
  - a) Belief in Allah (SWT);
  - b) Belief in Muhammad (PBUH) as the last of the prophets;
  - c) Belief in the Books of Allah (SWT);
  - d) Belief in the Angels;
  - e) Belief in the Day of Judgment;
  - f) Belief in Kadaa and Quadr.
- 3) A member should belong to the Ahl Assunna Wal Jama'as school of thought
- 4) A member must be at least 18 years old.
- 5) A member must be a resident of the greater Sacramento area. This includes Sacramento, Placer, Yolo, Eldorado, San Joaquin counties.
- 6) An applicant or a renewing member must pay the membership dues set by the Board of Trustees to become or to continue being a member.
- 7) The term of membership is one Hijri year, from the first of Ramadhan to the end of Shabaan. Membership is renewable within 30 days of the expiration date
- 8) Executive Committee will review and process new membership applications. The Executive committee reserves the right to deny membership to the applicant without disclosing the reasons.
- 9) The applicant has the right to appeal to the Board of Trustees if his application has been denied by the executive committee within 30 days of rejection.
- 10) MASJID ANNUR board of Trustees reserves the right to revoke the membership of any person without disclosing the reasons.
- 11) Withdrawal from membership may be voluntary or may be decreed by a majority vote of the Executive Committee for failure to continue to meet the qualifications mentioned in the previous sections
- 12) A person whose membership has been revoked for failure to meet the qualifications stated in 2 and 3 can only be reinstated by testifying to his/her beliefs in front of the Executive Committee. A person whose membership has been terminated for failure to meet the qualifications stated in 5 and 6 can be reinstated by applying for membership and paying the required dues.
- 13) All Communications will be in writing.
